Administered a one-to-one mail mentor program, in which incarcerated writers corresponded monthly with experienced writers and editors outside of prison. Incarcerated writers sent 20-40 pages of creative work each month, and mentors responded with detailed, personalized feedback, suggestions, and encouragement. Approx. 70 incarcerated writers participated in 2019.
